# **Survey Guidelines**

The 2011 Exotic Wood Borer/ Bark Beetle National Survey Guidelines has been finalized, and can be found at <u>http://caps.ceris.purdue.edu/survey\_manuals</u>. The 2011 version contains the Approved Methods for surveys in 2011. The EWB/BB Survey Guidelines will be updated for 2012 this fall, and will contain changes to the Approved Methods that will be implemented for 2012 surveys. # **Approved Methods**

There have been several recent changes and additions to the Approved Methods site (http://pest.ceris.purdue.edu/services/napisquery/query.php?code=cam2012).

- There has been a taxonomic name change for the Plum fruit moth in the Stone Fruit Commodity Pest List. *Cydia funebrana* has been changed to *Grapholita funebrana*. This change also has been made in the Stone Fruit Commodity documents. Please make sure your 2012 work plans reflect this change.
- A pest data sheet for *Diprion pini*, the Pine sawfly, has been posted. Additional pest data sheets will be posted for other pests as they become available.
- The approved method for *Lymantria monacha*, Nun moth, has been added to both the 2011 and 2012 Approved Methods. This pest has been a Farm Bill survey target. Asian

defoliators as a group will be available for surveys in 2013. The posting of approved methods for this pest initiates the process of having approved methods available for all pests in this group for 2013 surveys.

An email is sent from the CAPS R&C site when updates are made to the Approved Methods, with a subject line of 'New posts.' This occurs when Lisa or Melinda update the CAPS Approved Methods Change Log. Please pay attention to this email and the information it contains. ### **CAPS** Technologies Webinar

An email from Meeting Wizard has been sent out to those on the NCC call asking for your availability for a webinar that Terrence Walters will host to demonstrate several technologies that may benefit the CAPS program. Additional dates were added to the request. Please respond to your availability as soon as possible so we can confirm the date.

### **IPHIS Update**

The CAPS program currently is pursuing three major issues with IPHIS: 1) How to build the CAPS complex(es) that will be used to develop the data entry templates. Evidently with the way the system currently is designed, large complexes with many pests will not work in IPHIS. The system cannot handle the many linkages that need to occur. We have arrived at an option that may work, but this will involve development work by the contractors, and will incur costs. We are waiting to hear from the IPHIS Executive Steering Committee if funding is available and these costs will be approved at this time. 2) How to summarize data in IPHIS so that the appropriate data can be sent to NAPIS to support Pest Tracker. Also an issue is how to send the data. This must be worked out to avoid double data entry, once in IPHIS and summarized in NAPIS. Reporting functions in IPHIS may be able to do this now, but there is still some question as to whether or not the reporting functions exist and the appropriate data presently is being collected in IPHIS. 3) What minimal number of data fields is appropriate to for detection surveys in the CAPS program. Several versions of the suggested data fields have been sent to the NCC for sharing and discussions with their constituency. We want to make sure that when we submit this requirement to the Change Control Board that we have the consensus of the CAPS community. We are close to arriving at a final version. If you have not seen the latest version or participated in the discussion, contact your NCC representative. We want this to be as inclusive as possible. The downside is that this will incur development and costs to implement, and may have to wait until next year to implement. The sooner we submit a final version for consideration, the better off we will be.

Several items still need to occur and several issues need ironing out before we can commit to using IPHIS in 2012, although this still may happen. At present we are about 50:50 for using IPHIS or NAPIS in 2012. We may know one way or the other in a few weeks, but cannot commit to one way or the other right now. Much may depend on the available budget for IPHIS for the remainder of the calendar year. We need to put in an honest effort to determine if IPHIS



will work for CAPS before we resort to NAPIS again in 2012. As such, we cannot commit to any specific data management language in the work plan or agreement. Once we hear whether or not the development work in IPHIS can be accomplished before the end of the calendar year, then we will let everyone know what data management will look like in 2012. ### FY12 Budget

The FY12 budget is unknown at this time. We are expecting some reductions, but we do not know how much and where the impacts will be felt. Please pay attention to messages from the Regional Offices. Budget information will come from these offices as it becomes available.

### **CAPS and NCC Meetings**

If the CAPS Conferences are to be held every two years, as the CAPS community suggested, then the next one would be tentatively scheduled for December 2012 (in FY13). In the current budget and economic climate, we will have to investigate management's thinking for having the meeting, and provide good justification and ways to cut costs before a request for approval is submitted. We cannot really say yes or no right now, but we will look into putting in a request. At most, the request may be denied or deferred to the following year. In the meantime, the CAPS community needs to be thinking of possible alternatives to a large meeting...how could this be done and what would it look like. This meeting is important to the CAPS program, and we all need to find a way to get it done in whatever form it turns out to be.

A request for an NCC meeting toward the end of January will be submitted. Where?
