

The National CAPS Committee (NCC) meets annually to discuss the CAPS Survey Guidelines (due to be published in April for the 2012 survey year) and any changes that may be needed based on issues raised during the previous survey year and discussions with the various representatives' constituency. The NCC also needs to meet as a follow up to the National CAPS Conference held December 1-3, 2010, in Kansas City, MO. Many discussions were held during the CAPS Conference, and recommendations and suggestions from that meeting need to be acted upon and incorporated into the Survey Guidelines or other CAPS Program initiatives. This meeting will take those recommendations, prioritize, and develop action items with milestones and deadlines. The NCC also needs to discuss the transition from NAPIS to IPHIS for CAPS/Pest Detection data. Discussion of these items will begin before the meeting, and relevant material distributed in advance, but a 2-day, face-to-face meeting with discussion is needed to prioritize, assign responsibilities, and continue to move the CAPS program forward.

The meeting will be held on the Centennial Campus of NC State University in Venture II, Oak Island Conference Room #385, 920 Main Campus Dr., Raleigh, NC 27606.
