The 2010 National CAPS Conference took place in Kansas City, Missouri from Wednesday through Friday, December 1st through the 3rd, 2010. The conference was designed to be a working meeting, with the intent to obtain input from the States and field on a variety of issues. This is a major opportunity for all involved to participate in the future direction of the CAPS program, and come away with a sense of ownership in the program. We will face the future together!

Specifically, the planning team designed and developed strategies to enhance the meeting experience for participants to create an environment to facilitate networking, information exchange and discussions. What could have been done better or differently to improve the 2010 CAPS Conference?

- Use less paperwork number references and spell out the actual titles.
- Add another day. Hand out contact list of all attendees. Would like state personnel to present examples of their ops, activities. CAPS 101 could be longer, more detailed. Have simple background entertainment at banquet (liked the awards, they are important, but keep it short).
- I really enjoyed the exhibits. It would be better if there was more detailed information about the programs, exhibitors for us keeping in mind that we are not laymen and that we are already interested and that these exhibits may be our only contact to learn exactly what others are doing especially CPHST, outreach areas, NAPIS/IPHIS. It would be beneficial to have more details tailored to non-layman.
- CAPS: I'm less committed to outreach as being an important to Pest Detectors as the Trapping Program. One person asked if any pest were detected as a result of outreach, the answer was "0".
- SPHD: Disappointed by the PHP/AQI headquarters was not represented. There are often complaints that field is not caring about the SPHD's/Issues from questionnaire to SPHD's last spring were not addressed. Too much time to 106. Didn't get time to talk of difference between ER, WR and HQ, once discussion started.
- Eliminate the joint SPHD/CAPS arrangement.
- Another day too bad the meeting had to be shortened. It would have been nice to support New Orleans by going there for our meeting and somewhere a bit warmer would have been nice.
 It would have been helpful if Todd S. had given us a list of tablets, notebooks, pda's, etc. that people are currently using successfully with IPHIS. That way, those of us that need to purchase equipment would have a starting point of suggested items that might work for us. Right now I have no clue what to buy other than Windows and minimum OS. That seems a real crap shot with our very limited funds.
- Add an example or two of creative surveys performed as a presentation to meeting instead of limiting them to CAPS Fair display.

- Please provide outlet/plugs for people with laptops! Please provide lunch options to gather antisocial folks (have announcements to meet in lobby, etc.). Thursday breakout session (AHP list) was not a fruitful discussion I think we can have better topics where we really can contribute as a group to moving issues forward!
- A dictionary of acronyms included in the program; A directory of people and their roles to have handy for those that can't get online at the meeting; Maybe daily opportunities for breakouts and by roles.
- Conducting an NCC meeting at the national meeting is good holding it as an open meeting that conference participants could observe and see the committee members in action would be very interesting. Transparency in the CAPS program has been greatly improved in the past few years this would be another good step.
- Snacks at breaks. Hard to get back in time after lunch sometimes. Two and a half days seems that the events are crammed into such a short time frame (and) that makes for long days.
- Timing of meeting (week after Thanksgiving) is a terrible time for meeting/travel. This continues to be the time chosen for this meeting and needs to be changed. There should be presentations/sessions on work plan formats/preparation and financial paperwork. Also session combining SPHDS and BSC's in regional groups needed.
- Less time for CAPS Fair. Address e-commerce.
- Dedicated travel day on Friday. Half day not sufficient for all of us especially in winter with mountain passes to drive to get home. This is a safety issue. I left early because of it.
- Just a few nit-picky things: The breakout rooms were a bit small and microphone would have improved the experience, especially during the CPHST presentation. I think 1 or 2 more presentations could have been thrown in there seemed to be a lot of downtime.
 The coffee could have been better.
- I would have the breakout sessions by job title early in the conference. I would help people get to know each other early in the meeting and also ensure that people are still at the meeting and not left yet. Providing lunch at the conference allows for more time to network and meet new people.

- We really do need a little free time built in. We could use even more time in our peer groups. Many people in this group work out daily, so a hotel with adequate facilities is necessary. The breakout sessions were great, it would have been even better if we could have gone to several or even all of them.
- Breakout rooms needed mikes acoustics without were not adequate. Also prefer rooms equipped with table for east of note taking. Hearing over AC/heat was difficult.

Have a longer meeting leaving evenings (or at least most) free to do own thing, be it paperwork or tourism or networking. Would rather have a longer meeting that 2 days 8:00 a.m. - 9:00 p.m. each day – no time to visit host city or catch up with office responsibilities that don't disappear while we're attending meetings. Really enjoyed the CAPS Fair – just too much time allotted to it.

- Rooms <u>require</u> web access.
- Overall it was a very good meeting. I would like to see us have some discussion or workshops that we feel would benefit us. I like the Adult Lep workshop and the EWB and B____ workshops, but there might be others we could benefit from.
- Should have the meeting in New Orleans.
 Work with the states that didn't send representatives due to constraints. Reiterate the mandate of attendance as this meeting is federally funded and should not be impacted by state budgetary constraints.
 Lot of the new SSC's requested better training after assuming this new role.
 PSS's undergo 6 weeks (?) of training but none for SSC's. There was a couple that had some training by Susan S. That was invaluable.
- Somehow get the SSC to interact with others (hospitality room). Do they feel welcome?
- I would have liked to see more examples of state bundle surveys, either at the CAPS Fair or presentation.
 Microphones for the breakout sessions.
 More state involvement in meeting presentations.
- I would like to have attended <u>all</u> the breakout sessions.
- Perhaps a balance of presenters instead of all PPQ. May half state and half PPQ presenters.

• Before registration process, giving the opportunity for payment to debit or credit cards.

Better meeting rooms with audio systems _____ the occupancy levels.

- Cash only registration was a significant inconvenience. Having scheduled (albeit "optional") activities every evening was a bit exhausting and made me feel like I just spent 3 days inside a hotel. One or more of these events could have been held externally and formally out somewhere in Kansas City!
- While the CAPS Fair was good, too much time was devoted to it 2 hours would have been plenty.
 Not too much offered for morning breaks hot chocolate would be nice, not everyone drinks coffee.
 Ceceris talk should not have been on the last day. Many people missed the presentation because they were already gone.
- Breakout sessions with PSS and SSCs should include SPHDS/SPROS. End session when done, no need to keep group just for gaps in break service. Longer educational fair – not enough time to see network with all.
- I didn't feel like talks on the first day yielded me very much info.
- The late night meeting (SCC/PSS) was appropriate; however after a day of meetings, I don't believe you will get as much brain-storming if you hold it after hours maybe move to a day time session.
- The policy pontificating should be reduced. A frank evaluation of the need to have this meeting at this time was needed. With the CR in effect and CAPS funding on hold precluded a realistic discussion of future direction. I saw little buy-in to IPHIS from the states it was more attitude of "We've got to do what?" How will it affect cooperative agreements? Who will pay for extra reporting or equipment for the field? How will states access the IPHIS data? Legitimate questions that need states input.
- Don't end on a Friday at noon leave all Friday for travel.
- More interaction with State Plant Health Directors from other states. Networking sessions (reception) – should have been open to State Plant Health Directors.
- A bit more time to breakout by peer group. A longer session with a report generated from each group without necessarily a defined agenda.

- Handouts of slides would be helpful, in addition to posting them online after the fact. Microphones for breakout sessions.
- Need greater than 30 minute breakfast period. Breakfast is also a valuable time to interact with cooperators, PPQ staff, etc.
- The Friday morning session caused travel problems. Need meeting to end on time for travel home.
 Felt like the meeting was crammed into time allowed; realize problems with budget for meeting.
- Shorten the time for presentation to 15 30 minutes and give more different subject (particularly for survey, projects, etc.).
- Breakout sessions in smaller groups. Maybe break the Pathways groups into 6 8 smaller groups. Have small groups report back to whole Have each group have:

SSC Provide flipchart/small groups PSS Small groups report back ? SPHD ? SPRO Other Then get a consensus from the whole group. Can use flip chart sheets and then let everyone "vote" with 3 post-its. There are better ways to encourage exchange of info and get input. Have non-USDA people as well as USDA staff as session leaders.

- Need a microphone for Andy Kirk room.
- Don't require cash payment!!! Don't combine with other meeting. Too much time on outreach – non CAPS projects – none of this is funded by CAPS – if CAPS is considering <u>additional</u> funding for outreach, line out process, timeline, CAPS community input.
- CAPS Fair is important, but do we need to set aside 3 hours? Would like to see breakout sessions run more than once to give the attendees the opportunity to sit in on more than one session. I think there have other sessions that may be of value. More topics, discussions on CAPS related activities.

- The PSS/SCC networking session could have been held more informally maybe at the Lucky Strike Bowling Alley. Need a full 3 day meeting. The meeting should have been held Tuesday through Thursday with Monday and Friday as travel days only. The coffee was not very good but I'm a coffee snob.
- More state perspective on surveys/CAPS presentations (positives and negatives).
- More breakouts with peer groups. Have every speaker concentrate on things to help CAPS program. ______ on every aspect of the CAPS program. Breakouts need to be done at beginning of meeting and notes from breakout discussed during meeting, and talked about again if needed.
- Could do more activities to remix participants to encourage development of new relationships.
- CAPS 101

The first impression I had of National CAPS was the 101 session. It was a rushed meeting that dealt vaguely with a newcomer's role.

The first words spoken to the group by John Bowers was "Let's get started so we can get finished".

Either do not have a 101 session or spend more time giving attention to details that would be beneficial to a newcomer.

The breakout session "Are we targeting the right pest?" was good for discussing, but had difficulty answering the original question.

I enjoyed the session but it did not accomplish its purpose.
